## CONFIDENTIALITY AGREEMENT

Harvest Pack Inc

This Confidentiality Agreement & Non-Circumvention Agreement (“Agreement”) dated below by and between the undersigned (“Non-Disclosing Party”) and Harvest Pack Inc (“Disclosing Party”) regarding the development of business relationship between the parties.

Definitions:

a. Confidential Information.

For the purposes of this Agreement, “Confidential Information” shall mean any and all discoveries, ideas, facts, data, databases, books, files and records, or any other information of whatever type and in whatever form, that is not publicly known, and that is disclosed or otherwise made available to the Non-Disclosing Party by the Disclosing Party or that was developed by the Disclosing Party, alone, or with others.

b. Trade Secret.

For the purposes of this Agreement, “Trade Secret” shall mean any and all Confidential Information that derives independent economic value, actual or potential, from not being generally known to the public or to other persons who can obtain economic value from its disclosure or use.

For good and adequate consideration, the parties intending to be legally bound agree as follows:

1. Non-Disclosure.

Non-Disclosing Party represents, warrants and understands that any and all Confidential Information and Trade Secrets that are received or developed by the Disclosing Party, or by a contact of the Disclosing Party, during the Term hereof, pursuant to this Agreement, or pursuant to any Definitive Agreement, are disclosed to the Receiving Party in strict confidence. The Receiving Party hereby agrees that during the Term hereof and for a period of three (3) years thereafter, the Receiving Party will not directly, or indirectly, except as required by law, or except as expressly consented to, in writing, by a duly authorized officer of the Disclosing Party: (a) disclose, publish, or make available, other than to an authorized employee, agent, officer, or director of the Receiving Party, any Confidential Information or Trade Secrets; (b) sell, transfer, or otherwise use or exploit the Confidential Information or Trade Secrets; (c) permit the sale, transfer, use, or exploitation of any Confidential Information or Trade Secrets by any third parties; or (d) remove from the Disclosing Party’s premises, or retain upon termination, any Confidential Information, or Trade Secrets, any copies of them, or any other tangible items containing, or constituting, Confidential Information or Trade Secrets.
